Criminal law | Law Society of Scotland Scottish criminal law matured much later than the civil law. There is no criminal code, and criminal procedure is largely regulated through statute. Since the House of Lords has no jurisdiction to hear Scottish appeals, there has not been the same pressure to assimilate Scottish and English criminal law. housebreaking has to be connected with theft; there is no crime of “housebreaking with intent to assault”. It is either theft by housebreaking or housebreaking with intent to steal.
