If the applicant is a minor (i.e. below 18 years of age at the time of application), any of the documents as per the lists specified below of any of the parents/ guardian of such minor shall be deemed to be the proof of identity and address of the applicant. TIN The TAN or Tax Deduction and Collection Account Number is a 10 digit alphanumeric number required to be obtained by all persons responsible for deducting or collecting tax. Under Section 203A of the Income Tax Act, 1961, it is mandatory to quote the Tax Deduction Account Number (TAN) allotted by the Income Tax Department



(ITD) on all TDS returns. Apply for Tan - Online Tan Application Form, Correction ... No documents are required to be submitted along with application for allotment of TAN.
